Operating from two strategic locations—a state-ofthe-art recycling facility in Smeaton, near Edinburgh

and a dedicated depot at the ATL Environmental Village in Bishopbriggs, Glasgow—the company delivers innovative and sustainable waste management solutions to a wide range of clients.

In November 2023, Hamilton Waste & Recycling Ltd was acquired by Biffa, further strengthening its capabilities and aligning with Biffa's mission to drive the UK's circular economy through industry-leading recycling and resource management.

Our Smeaton recycling centre:

Location: Off the Edinburgh Bypass/Al, near the village of Carberry

Site Size: 15-acre purpose-built facility

Capabilities:

- Recognised as one of Scotland's most technologically advanced recycling centres
- Licensed to process up to 1,000,000 tonnes of waste annually
- Core objective: Recycle 100% of incoming material and achieve zero landfill diversion

Bishopbriggs Depot:

Location: ATL Environmental Village, Glasgow

Role:

- Key operational hub for collection, logistics, and waste transfer
- Supports efficient waste handling and timely service delivery
- Enables Hamilton Waste & Recycling Ltd to maintain high service standards across central Scotland

Typical Materials Processed at Smeaton Recycling Centre

- Construction waste: Used as feedstock for Solid Recovered Fuel (SRF) for cement works
- Recycled aggregates: Clean materials (e.g., 6F5 or Type
 produced for reuse
- **Residual waste:** Sent to local waste-to-energy facilities, diverting from landfill
- **Timber:** Processed for reuse in board mills or as biomass fuel
- Metals: Recovered and sold to merchants
- Food waste: Treated via Anaerobic Digestion to generate renewable energy
- Plastics and films: Sorted and supplied to recyclers and end processors
- Brick, rubble, and soil: Screened, graded, and sold for reuse
- Cardboard and paper: Baled and sent to recyclers and paper mills
- Glass: Processed and sold for reuse
